In 2022 ANZATS established two book prizes to support excellence in publication of theological research, one for any book and the other for a book published by an early career academic. The Association is delighted to announce the winners of the inaugural competition at the 2023 ANZATS Conference, with each receiving a cash prize of \$1,000:

The ANZATS Award for Best Monograph goes to **Dr Anne Elvey** for *Reading with Earth: Contributions of the New Materialism to an Ecological Feminist Hermeneutics* (T&T Clark 2023).

The ANZATS Award for Best Monograph by an Emerging Scholar goes to **Dr Barbara Deutschmann** for *Creating Gender in the Garden: The Inconstant Partnership of Eve and Adam* (T&T Clark, 2022).

Congratulations to the winners and finalists and to all who submitted entries that showcased the quality of theological scholarship in Australia and Aotearoa. The ANZATS Council looks forward to announcing details of the next round of awards in the near future.

# Established Scholar Award – Judges' Report

The inaugural ANZATS Award for Best Monograph by an Established Scholar was open to any resident in Australia or New Zealand for books published within two years of submission. 12 submissions were received for books released between 2020 and 2022 on topics including science, ecological readings, trauma, ecclesiology and eschatology, Christian identity, performance criticism, Wesleyan studies, metaphysics, Christian-Muslim relations, Bonhoeffer, Australian Anglicanism, and biblical studies.

The judges would like to acknowledge the exceptional quality of all of the books that were submitted. It was a pleasure to read and learn from the breadth of theological scholarship being done in Australia and Aotearoa.

The judges awarded the prize to Anne Elvey for her book *Reading with Earth: Contributions of the New Materialism to an Ecological Feminist Hermeneutics* (T&T Clark 2023). This is a stunning book; it is beautifully written, academically rigorous, wide-ranging and highly original.

We also highly commended two authors as finalists: Doru Costache's *Humankind and Cosmos* and Dianne Rayson's *Bonhoeffer and Climate Change*.

## **Emerging Scholar Award: Judges' Report**

The inaugural ANZATS Award for Best Monograph by an Emerging Scholar was open to early career researchers who are resident in Australia or New Zealand for books published within two years of submission. 13 submissions were received for books released between 2020 and 2022 by a range of prestigious publishers. The judges were delighted by the quality of the submissions which ranged across a broad range of areas including biblical languages, biblical studies, systematic theology, philosophy, literature, film, and history, as well as several interdisciplinary works. This is a very encouraging sign for the future of theology in this part of the world.

The judges assessed the submissions on the basis of their overall scholarship and presentation, including mastery of their area, originality of the contribution, and the extent to which the author has found their own voice.

Three finalists were chosen that stood out from other entries due to the impact of their works, whether on contemporary debates in the churches and wider community or on the future of theological scholarship itself.

Samuel J. Freney's book on verbal changes in New Testament quotations from the Septuagint demonstrates exceptional scholarship in the disciplines of linguistic theory, Greek language in the Hellenistic and early Roman imperial period, and biblical studies. The book is sophisticated in its understanding of the field, the issues involved, and in its argument. It persuades us to view such verbal changes as natural to the narrative process and has flow-on implications for how scholars approach quotation of Greek scripture in early Christian preaching and writing.

Daniel R. Patterson's book is a courageous and relevant work engaging the writings of gender theorist Judith Butler, in dialogue with Biblical themes that emerge from Genesis 2-3. Adapted from the author's PhD thesis, with a new final chapter, the book draws on the genres of biography, autobiography, and poetry, as well as the disciplines of philosophy, Christian ethics, systematic theology, and biblical studies. It stood out not just for the command displayed, but its accessibility to a wider audience.

The winner is Barbara Deutschmann for *Creating Gender in the Garden*. This book, adapted from the author's PhD thesis, demonstrates an impressive command of a wide range of disciplines including languages, biblical studies, reception studies, history and contemporary gender theory. The book encourages Christians to reassess their assumptions about the nature of gender based on a rereading of Genesis, and has the potential to make a powerful impact on the future of the church.
